The Municipality of Guagua, Province of Pampanga through the **Early Childhood Care and Development Council** intends to apply the sum of **Two Million Four Hundred Ninety Nine Thousand Eight Hundred Ninety Seven Pesos and 93/100 (Php2,499,897.93)** being the Approved Budget for the Contract (ABC) for payment under the contract for: **LGU GUA 13-21 National Child Development Center**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The *Municipality of Guagua* now invites bids for *the above-mentioned project*. Completion of the Works is required within **120 calendar days**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project.
2. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from *the Municipality of Guagua* and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee of **Php5,000.00**.
6. The Municipality of Guagua will hold a **Pre-Bid Conference** on **March 15, 2021 (Monday) 2:00 pm** at Municipal Auditorium, 4th Floor, Municipal Building, Municipality of Guagua, Pampanga, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before **March 29, 2021 (Monday), 1:00 pm** at Municipal Auditorium, 4th Floor, *Municipal Building, Municipality of Guagua*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
8. Bids will be opened in the presence of the bidders, bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.
9. The Municipality of Guagua reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
