- 2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 3. Delivery of the Goods is required within thirty (30) calendar days upon receipt of Notice to Proceed (NTP) and door to door delivery to the location/recipient. Bidders should have completed, within the last three (3) years from the date of submission and receipt of bids, a contract similar to the Project, the value of which must be at least 50% of the Approved Budget for the Contract (ABC). The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- 4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criteria as specified in the Revised Implementing Rules and Regulations IRR of the Republic Act 9184, otherwise known as the "Government Procurement Reform Act".
