The Municipality of Guagua, Province of Pampanga through the **20% Development Fund CY 2021** intends to apply the sum of **One Million Three Hundred Fifty Thousand Pesos (Php 1,350,000.00)** being the Approved Budget for the Contract (ABC) for payment under the contract for: **LGU GUA 58-21 Improvement of Sto. Niño Road, Brgy. Sto. Niño**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The *Municipality of Guagua* now invites bids for *the above-mentioned project*. Completion of the Works is required within **120 calendar days**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project.
2. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from *the Municipality of Guagua* and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee of **Php5,000.00**.
6. The Municipality of Guagua will hold a **Pre-Bid Conference** on **November 19, 2021 (Friday) 2:00 pm** at Municipal Auditorium, 4th Floor, Municipal Building, Municipality of Guagua, Pampanga, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before **December 02, 2021 (Thursday), 1:00 pm** at Municipal Auditorium, 4th Floor, *Municipal Building, Municipality of Guagua*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
8. Bids will be opened in the presence of the bidders, bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.
9. The Municipality of Guagua reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
