FOR

Procurement of Nutribuns with Pumpkin for the Supplemental Feeding Cycle 11 (LGU GUA 49-21)

THIS AGREEMENT made and entered into this 2nd day of December, 2021 between the <u>MUNICIPALITY OF</u> <u>GUAGUA</u> represented by <u>HON. DANTE D. TORRES</u>, Municipal Mayor and duly authorized for the purpose and hereinafter referred to as the <u>IMPLEMENTING AGENCY</u> and <u>CAFÉ NOELLE</u> as the <u>Supplier</u> with business address at KM 76, Greenfields Square, Mc Arthur Highway Sindalan, City of San Fernando, Pampanga represented by <u>JUDY G. USON, Proprietor</u>, duly authorized for this purpose and herein referred to as the <u>SUPPLIER</u>.

WHEREAS the Municipality of Guagua invited Bids for procurement of nutribuns for the project: **Procurement of Nutribuns with Pumpkin for the Supplemental Feeding Cycle 11 (LGU GUA 49-21)**, for the sum of **Nine Hundred Thousand Pesos (Php900,000.00)** hereinafter called "the Contract Price".

WHEREAS, the whole delivery of this project as covered by this CONTRACT shall be completed within <u>Thirty</u> (30) CD in accordance with the provisions of the Bid Documents;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - f) Notice of Award to Contractor and Contractor's Conforme thereto
 - g) Other pertinent documents as may be required
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
