CONTRACT AGREEMENT

FOR

REBID - Food for Work Project (for victims of Ulysses Typhoon and flood), Guagua, Pampanga (LGU GUA 21-21)

THIS AGREEMENT made and entered into this 12th day of July, 2021 between the <u>MUNICIPALITY OF GUAGUA</u> represented by <u>HON.DANTE D. TORRES</u>, Municipal Mayor and duly authorized for the purpose and hereinafterreferred to as the <u>IMPLEMENTING AGENCY</u> and <u>GARBES DIZON AND SONS, INC.</u> as the <u>Supplier</u> with business address at Mc Arthur Highway, Juliana, City of San Fernando, Pampanga represented by <u>ROZELLE MONTEMAYOR</u>, <u>Authorized Representative</u>, duly authorized for this purpose and herein referred to as the <u>SUPPLIER</u>.

WHEREAS the Municipality of Guagua invited Bids for procurement of various food stuff for the project: REBID - Food for Work Project (for victims of Ulysses Typhoon and flood), Guagua, Pampanga (LGU GUA 21-21), for the sum of Five Hundred Sixty Nine Thousand Two Hundred Fifteen Pesos (Php569,215.00) hereinafter called "the Contract Price".

WHEREAS, the whole delivery of this project as covered by this CONTRACT shall be completed within <u>Thirty</u> (30) CD in accordance with the provisions of the Bid Documents;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this agreement words and expressions shall have the same meanings as are respectively assigned in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be rear and construed A Part of this Agreement, viz.:
 - a) The Bid Form accomplished and submitted by the Contractor including the following annexes:
 - I) Sworn Statement
 - Bid Form/Schedule submitted by the Bidder;
 - III) Delivery Schedule
 - b) Contract Agreement
 - c) Invitation to Bid
 - d) Performance Bond
 - e) Post Qualification Statements
 - f) Notice of Award to Contractor and Contractor's Conforme thereto
 - g) Other pertinent documents as may be required
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
