- 2. The starting bid price is **ONE HUNDRED THOUSAND PESOS (PhP 100,000.00)**. The winning bidder shall demolish and clear the area. In exchange for the auction value invested, the winning bidder can resale the scrap materials or any means they wanted.
- 3. Bids received below the Floor Bid Price shall be automatically rejected at bid opening. The award shall be given to the highest complying bidder, as determined by this Committee.

Bidders shall submit its duly signed and accomplished Bid Tender Form accompanied by a valid and current Mayor's/Business Permit and Bid Bond equivalent to at least ten percent (10%) of the minimum bid price set by the Municipality in any of the acceptable forms. The bid tender shall consist of at least three (3) copies. The envelope containing the bid tender shall be properly sealed and signed and addressed properly and correctly.
- 5. The demolition and clearing of the area is required to be completed within thirty (30) calendar days upon receipt of the Notice to Award (NOA).
