 TO BE USED BY LEARNERS OF GUAGUA EAST DISTRICT  
 (DC 02-24)**

THIS AGREEMENT made and entered into this 5<sup>th</sup> day of July, 2024 between the **MUNICIPALITY OF GUAGUA** represented by **HON. ANTHONY JOSEPH S. TORRES, Municipal Mayor** and duly authorized for the purpose and hereinafter referred to as the **IMPLEMENTING AGENCY** and **PLL PUBLISHING CORPORATION** as the **Supplier** with business address at 50-C Saint Martin St., Reymar Subd., Tandang Sora, Quezon City, represented by **GEORGE ALLAN L. LUCZON, President**, duly authorized for this purpose and herein referred to as the **SUPPLIER**.

WHEREAS, the Municipality of Guagua invited and requested for the submission of quotation for the procurement of books for the project: **Procurement of 740 copies of Books entitled "Building Effective English Skills 4" to be used by learners of Guagua East District (DC 02-24)**, for the sum of **TWO HUNDRED NINETY NINE THOUSAND SEVEN HUNDRED PESOS (Php 299,700.00)** hereinafter called "**the Contract Price**".

WHEREAS, the whole delivery of this project as covered by this CONTRACT shall be completed within **Thirty (30) Calendar Days** in accordance with the provisions of the Request for Quotation;

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this agreement words and expressions shall have the same meanings as are respectively assigned in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be rear and construed A Part of this Agreement, viz.:
  - a) The Request for Quotation accomplished and submitted by the Contractor including the following annexes:
    - I) Schedule of Requirements
    - II) Technical Specifications;
    - III) Financial Proposal Submission Sheet
  - b) Contract Agreement
  - c) Resolution for the Single Calculated and Responsive Quotation
  - d) Notice of Award to Contractor and Contractor's Conforme thereto
  - e) Other pertinent documents as may be required
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
